DEALER DIRECT Dornaus & Dixon Enterprises, Inc. will wholesale Bren Ten firearms and accessories to all current Class 1 Federal Firearms Licensed dealers within the United States. All firearms and accessories are marketed dealer direct. All orders are to be placed directly with the manufacturer by the dealer, and are shipped directly to the dealer from the manufacturer. **MARK-UP** The mark-up from wholesale to manufacturer's suggested retail price is 25% of retail on firearms, and 33% of retail on accessories and ammunition. We do not set the price of the ammunition, this is done by the ammunition manufacturer. **SHIPPING** All shipping is done by UPS (or equivalent carrier), with the shipping costs payable C.O.D. by the dealer. **MINIMUM ORDER** Minimum acceptable initial order is one (1) Bren Ten. **STOCKING DEALERS** To qualify to become an Authorized Bren Ten Stocking Dealer, a minimum of three (3) Bren Tens must be ordered. If two or more of the Bren Tens ordered are of different models, those models can have matching serial numbers, at the stocking dealer's option. **TERMS** Terms on initial order are: 50% down payment at time of order; balance due at time of shipment. Method of payment may be either personal check, business check, money order, or charge card (Cashier's checks and certified checks are not necessary). If a charge card is used, indicate which charge card you are using, the charge card number, and the charge card's expiration date. Only VISA and MasterCard charge cards are accepted. After initial order: C.O.D. accepted upon establishment of credit. Open Account available to established Stocking Dealers who purchase ten (10) Bren Tens or more after initial order and establishment of credit. Open Accounts payable 2% discount if payment received within 10 days, net due 30 days. To establish credit after initial order, submit credit references. **DISCOUNTS** Established Open Accounts: 2% 10, Net 30. Bulk lot prices for the 10mm Auto ammunition are available for 30 case lots or more. Specific prices quoted individually depending on quantity ordered. No other discounts are available. **DEALERSUPPORT** All Authorized Bren Ten Dealers, who are a part of the National Bren Ten Dealership Network, are provided with high impact, point-of-sale promotional material, national advertising support, a comprehensive factory service program, and prompt product delivery. All firearms and accessories, and the materials they are made from, are completely made in the United States.

Use care and consideration when ordering. Orders cannot be changed once they have been processed.
